The growth in demand for critical minerals offers a renewed opportunity for mineral-rich countries to lock in value domestically. Fiscal policy is an important lever that governments can pull to incentivize value addition. Some of these fiscal tools include the creation of special economic zones, export restrictions, investment allowances, and variable rate royalties to support in-country mineral processing. This session explores the opportunities and limits of fiscal policy measures in promoting value addition along the mining value chain for critical minerals.
